BILL #18 – RESOLUTION - PROCLAIMING THE MONTH OF APRIL 2022 AS “FAIR HOUSING MONTH” IN THE CITY OF MCKEESPORT.

BILL #19 – RESOLUTION - AWARDING THE BID FOR THE MCKEESPORT RISING DEMOLITION PROJECT PHASE 6 TO BETTERS COMPANY, INC., AND AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE ALL DOCUMENTS NECESSARY TO ENTER INTO AN AGREEMENT WITH BETTERS COMPANY, INC.
